## GIFT AID DECLARATION

I would like Counties to treat all donations I have made for the **four years** prior to this year and all future donations I make as Gift Aid donations. I confirm that I pay UK Income Tax and/or Capital Gains Tax at least equal to the tax Counties reclaims in each tax year (6 April one year to 5 April the next) and will notify Counties if I cannot fulfil this requirement.

### Notes:

- All Gift Aid donations must be supported by a valid 'Gift Aid declaration'. Please complete the form as **fully as possible** and do not add any additional notes or explanations. Please notify us of any **changes in circumstances** e.g. changes of address, if you wish to cancel this declaration, or if you no longer pay sufficient tax on your income and/or capital gains.
- **Tax claimed:** Counties can reclaim 25p of tax on every £1 you give after 5 April 2008.
- HM Revenue & Customs will not allow Gift Aid to be claimed on a gift where the donor **requires** that the charity use funds in a certain way. Please read the consequent wording that follows before signing the form, as a signature will be taken as acceptance of the conditions under which Gift Aid tax is reclaimed.  
*Where a donation is given with an **expressed wish** for the allocation of the funds the Trustees will consider the donors wishes in the light of the objectives of the charity. Please let us know if you wish any donation to remain anonymous.*
- Special rules apply to donations made by **connected persons** (including lineal descendants, 'in-laws' & business partners).
- If you pay Income Tax at the higher rate, if you want to receive the additional **tax relief due**, you must include all your Gift Aid donations on your Self Assessment tax return.
